**Desired outcome:** Action items that can increase public awareness about safety and achieve desired behaviors without restricting the enjoyment of the trail and the parks DISCUSSION:

### Perceived safety & etiquette issues

- Speed
- Warning
- Trail width
- Vegetation management

### Objectives

- Consistent messaging by all stakeholder groups
  - o PUD

### Target audience and message content

- Cyclists
  - o Trail etiquette
  - o Speed limit
- Walkers and Runners

  - Wearing head-sets and not hearing/heeding warnings

  - o Shorter leashes

- Audit vegetation over-growth and plan for clearance
- Purchase trail stencil and share
- Help promote Goat Head removal effort (link to website)


